Ingredients	Beef steak (47%), gluten free flours (rice flour, tapioca starch, chickpea, vegetable oils & fats, gravy thickener (1412), salt, vegetable oil, hydrolysed vegetable protein, colour (150c), rice flour, spices & flavor)), sugar, salt, pepper, raising agent (500), flax seed, xanthan gum (415), glucona delta lactone (575).

Packaging - Primary	Commercial foodgrade cake boxes with foodgrade instruction labels applied
Storage Conditions	Keep frozen until the day of use
Distribution Method	Freezer delivery truck. Place into freezer storage on receipt of orders.
